## **Voter Service Committee**

- 1. Educate voters in general, and Cook County Local Leagues and members in particular, on election information and the County offices, candidates, and County-wide referenda for upcoming elections
- 2. Work with the Cook County Clerk's election division and the Chicago Board of Elections to improve the voting process for all Cook County voters

#### **Observer Corps**

Observe and report on the meetings of the Boards of Cook County, Cook County Health, Forest Preserve District, and Metropolitan Water Reclamation District on our website under "Observer Reports"

## Cook County & MWRD Governments Interest Group

Continue to learn about, monitor, examine, and take action when appropriate regarding Cook County and the Metropolitan Water Reclamation District governments, focusing on

- a. Transparency and effectiveness of Board operations
- b. Boards' oversight of spending and programs, including use of appropriate performance objectives and measures
- c. Inspector General reports and follow-up, and ethics

#### **Cook County Health Interest Group**

Monitor and report on

a. CCH committee and board decisions, focusing on Financial, Human Resources, and Quality of Care issues, and new partnerships, projects, and services undertaken by CCH and its Board

b. CCH's Medicaid Managed Care Plan (County Care), focusing on the newly expanded State Medicaid

- immigrant health program and the impact of the long-delayed State redetermination of eligibility
- c. post-Covid issues including mental and behavioral health challenges and services

#### **Criminal Justice Interest Group**

- 1. Monitor the implementation in Cook County of the provisions of the SAFE-T Act, particularly those concerning pretrial procedures.
- 2. Monitor and examine within Cook County
  - a. Diversion programs and Electronic Monitoring
  - b. Mental health issues within the criminal justice system
  - c. Equal justice throughout the criminal justice system
  - d. Objective and uniform data collecting, sharing and reporting among all stakeholders

#### **Forest Preserve District Interest Group**

- 1. Monitor
  - a. land acquisitions and restoration efforts by the FP
  - b. capital improvements made and proposed by the FP in the preserves and at Brookfield Zoo
- 2. Offer guided walks in the woods to League members

# SUMMARY OF LWVCC POSITIONS

**COUNTY GOVERNMENT**—Supports measures that improve the structure and function of Cook County government, including retention of single-member districts, separation of powers, a timely budget process, government transparency, standards for elected vs. appointed offices and/or consolidation of offices, inter-governmental cooperation, and performance management.

**CRIMINAL JUSTICE**—Supports measures that improve adult corrections and the criminal courts, increase and improve diversion programs, and improve judicial sentencing and oversight of correctional facilities.

**HEALTHCARE**—Supports measures that provide public health facilities that are accessible to those who need services, and provides for citizen input in planning for health care with emphasis on cost containment and consumer involvement.
